It is understood that this authorization is given in advance, but is given to provide authority and power on the part of the Agent to give specific consent to any and all such examinations, anesthetics, diagnosis, treatment, or hospital care which the aforementioned surgeon, physician and/or dentist, in the exercise of his/her best judgment, may deem advisable. This authorization is given pursuant to the provisions of the laws of the State/Country in which the medical or dental care is being sought. The Parent/Guardian hereby authorizes any hospital which has provided treatment to the Minor to the Agent upon the completion of treatment. This authorization is given pursuant to provisions of the laws of the State or Country in which the medical or dental care is being provided. The Parent/Guardian hereby agrees to pay all costs of medical or dental care incurred for the Minor by the Agent, or the Organization, under this authorization. Also, I the undersigned further state that I do hereby grant to the *Youth Pastors/Directors/Sponsors* full power and authority to control and discipline the aforementioned child/teen, but that such authority shall not extend to or include any form of physical corporal punishment to said child/teen.
